

The Essentials in a Nutshell

Focused learning units—Individual Master Classes are 3 to 4 hours long and take place online or in person. They are intensive learning units that require active participation and serve the needs of experienced participants from the banking and finance industries.

- A university background or corresponding professional qualifications.

Certification and SAQ

Each participation in a Master Class is confirmed by a certificate issued by the Swiss Finance Institute.

Master Classes are recognized as four-hour SAQ recertification measures. Corresponding certificates of attendance will be issued upon request.
